However, for countries that are *not* part of the Hague Convention, you'll need to go through a lengthier process of certificate attestation, which often involves several layers of verification: first by a local notary, then by state-level authorities, next by the Ministry of External Affairs or equivalent federal body, and finally, legalization by the embassy or consulate of the destination country.
